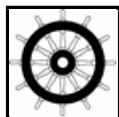

Product description

"Class A60 Deck (HYSF-64-DECK)"

Is a steel deck composed of single layer of 30 mm thick HYSF type Huayuan Marine Super Fireproof Wool (density 64 kg/m³, produced by Zibo Huayuan New Materials) applied on a steel structural core containing the angle stiffeners in size L100 x 70 x 8 mm, spaced 600 mm apart. A flat steel sheet of 100 mm x 8 mm dimension is welded in horizontal direction at front and rear ends of the deck.

The insulation is fixed by means of steel pins (Ø3 mm) and steel fastening washers (Ø30 mm).

The pins between stiffeners are to be installed with maximum longitudinal and horizontal distance of 300 mm. The pins on stiffeners are positioned at nominal spacing of 160 mm from the insulation edge. The maximum distance between pins on the stiffeners and pins on the structural core steel plate is 150 mm.

For further details see drawing listed under Type Examination documentation.

Application/Limitation

Approved for use as a horizontal fire retarding division of class A-60.

The insulation materials and adhesives used have to be approved according to the Marine Equipment Directive and bear the Mark of Conformity. This requirement may also be applicable for surface materials used, if required by relevant rules and regulations.

Each product is to be supplied with its manual for installation and maintenance.
