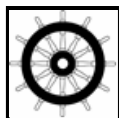

is a laminate used as surface material for furniture parts, wall- and ceiling panels, applied with primer or adhesive.

Maximum thickness: 0.18 mm
Density: 1.4 g/cm³

Application/Limitation

Approved for use as low flame spread material, not generating excessive quantities of smoke nor toxic products in fire.

Any adhesive used, other than the one used during testing, has to be tested for low flame spread characteristics according to IMO 2010 FTP Code Part 5 and to be approved according to the Marine Equipment Directive and bear the MED Mark of Conformity.

The product satisfies the requirement for maximum calorific value (SOLAS Reg. II-2/5.3.2.2) without further testing.
