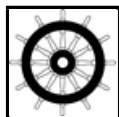

Paint system consisting of:

1. one layer of 0,04 mm (dry film thickness) primer "Bolidt Primer PU/LP 2580", a coating based on polyols and polyisocyanates.
2. one layer of 0,1 mm (dry film thickness) topcoat "Bolidt Coating PU/SH-Y", a two-component coating based on polyols and polyisocyanates.

Mixing ratio layer 2:

A (coloured): B (transparent): 66,7 wt% : 33,3 wt%

Maximum thickness: 0,14 mm (dry film thickness).

Density: 1,64 kg/m³

Application/Limitation

Approved for use as low flame spread material, not generating excessive quantities of smoke nor toxic products in fire.

Approved for use as paint systems on a metallic substrate with thickness of at least 2.25 mm.

Approved for all colour variations.

Maximum organic content: 40,3 wt% per dry film thickness.

The product satisfies the requirement for maximum calorific value (SOLAS Reg. II-2/5.3.2.2) without further testing.

Each product is to be supplied with its manual for application and maintenance.
