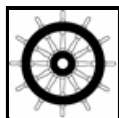

Application/Limitation

Float-free Data Recording Capsules (FFC) of types HLD-FFC600 and HLD-FFC660 are not allowed to be installed in its functional positions on board ships sailing under EU-flag for the first time after 2025-07-01.
