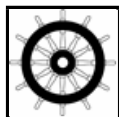

“Deck/A-60 Class SOF-S30-TEX”

Is a steel deck composed of steel plate cover with single layer of 30 mm thick SOF-S30-TEX insulation with Model No. #200 Metal Lath (density 1300 kg/m³, produced by Orion Industrial) applied on a steel structural core containing the angle stiffeners in size L100 x 75 x 7 mm, spaced 600 mm apart.

Application/Limitation

Approved for use as a horizontal fire retarding division of class A-60.
