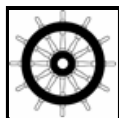

is a low flame-spread material consisting of glass fibre fabric and flame-retardant adhesive (manufactured by Yixing Kunhao Fireproof Material) for use on bulkhead, lining or ceiling materials.

Surface density: 100±10 g/m²

Nominal thickness: 0.1 mm

Approved for use as low flame spread surface material, not generating excessive quantities of smoke nor toxic products in fire.

Approved for use as decorative veneers on any non-combustible substrate.

Approved colour: white

Max. organic content: 0%

Any adhesive used, other than the one used during testing, has to be tested for low flame spread characteristics according to IMO 2010 FTP Code Part 5 and to be approved according to the Marine Equipment Directive and bear the Mark of Conformity.

The product satisfies the requirement for maximum calorific value (SOLAS Reg. II-2/5.3.2.2) without further testing.

Each product is to be supplied with its manual for installation and maintenance.
