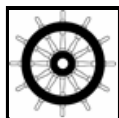

Product description

“Marine B50MGd Type Class B-15 Bulkhead”

is a panel consisting of a 48.8 mm thick YG-2 type rockwool insulation (manufactured by Changzhou Thermal Insulation Material Factory Co., Ltd. with a density of 120 kg/m³) covered with 0.6 mm thick galvanized steel plates on both sides by means of an adhesive of type PAPU-03 produced by (Jingjiang Green Functional Material Co., Ltd.).

Total panel thickness is 50 mm.

The panels are joined together by flat steel connectors 30 mm x 3 mm (W x H).

The panel can be fitted with two cable trays 200 mm x 22.4 mm (W x H) made of 1.2 mm steel. Space between cable trays is 50 mm.

Application/Limitation

Approved for use as a vertical fire retarding division of class B-15.

Maximum panel size: 2970 mm x 600 mm (H x W)

The insulation materials and adhesives used have to be approved according to the Marine Equipment Directive and bear the Mark of Conformity. This requirement may also be applicable for surface materials used, if required by relevant rules and regulations.

Each product is to be supplied with its manual for installation and maintenance.
