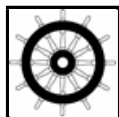

Product description

"TNF TYPE A25 B15 Class Ceiling"

Ceiling panels consisting of one layer of 23.5 mm thick BSS type rock wool insulation (density 120 kg/m³, produced by Weihai Bosheng Advanced Materials), covered on both sides with 0.5 mm thick galvanized steel sheets. The steel sheets are glued to the rock wool with the adhesive ICEMA R145/12 type, produced by H.B. Fuller Adhesives.

The plates are connected to each other by means of wedge joints, with 21 mm deep wedge cuts.

The ceiling is suspended below the deck structural core with L70 mm x 70 mm x 7 mm angle steels at four corners of the ceiling. The air gap between the ceiling and "A" class deck structural core is 420mm.

Total panel thickness: 25 mm

Application/Limitation

Approved for use as a horizontal fire retarding division of class B-15.

Maximum panel size: 618.5 mm x 3000 mm (W x L)

The insulation materials and adhesives used have to be approved according to the Marine Equipment Directive and bear the MED Mark of Conformity. This requirement may also be applicable for surface materials used, if required by relevant rules and regulations.

Each product is to be supplied with its manual for installation and maintenance.
