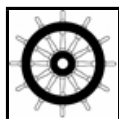

"HM-DECORATIVE PVC FILM "

Main components of materials: PVC Resin, non-toxic stabilizer, internal and external sliding processing AIDS and organic pigments.

Nominal thickness: 0.18 mm PVC film + 0.32 mm steel plate

Nominal density: 1.35 - 1.46 g/cm<sup>3</sup>

### Application/Limitation

Approved for use as low flame spread material, not generating excessive quantities of smoke nor toxic products in fire.

Approved for use as decorative veneers on any non-combustible substrate.

Approved for all colour variations

Maximum organic content: 74.3%

Any adhesive used, other than the one used during testing, has to be tested for low flame spread characteristics according to IMO 2010 FTP Code Part 5 and to be approved according to the Marine Equipment Directive and bear the Mark of Conformity.

The product satisfies the requirement for maximum calorific value (SOLAS Reg. II-2/5.3.2.2) without further testing.

Each product is to be supplied with its manual for installation and maintenance.
