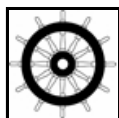

The adult lifejacket is approved for persons of more than 43 kg and a minimum height of 155 cm.

Retro-reflective material and position indicating light shall be approved in accordance with the Marine Equipment Directive (2014/90/EU) and bear the Mark of Conformity.

The design assessment is based on IMO Res. MSC.48(66) as amended by IMO Res. MSC.207(81), IMO Res. MSC.218(82), IMO Res. MSC.368(93), IMO Res. MSC.481(102) and IMO Res. MSC.554(108).

IMO MSC/Circ.922 regarding thermal protective lifejackets (TP lifejackets) is not applicable for this type of lifejackets.
