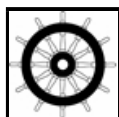

is a solvent-based, pigmented two-component polyurethane sealer (component A (main component) and B (hardener)):

- Maximum thickness: approx. 80 µm ± 30 µm
- Density: 1.7 g/cm³

Application/Limitation

Approved for use as low flame spread material, not generating excessive quantities of smoke nor toxic products in fire.

Approved for use as floor covering on any low flame-spread floor covering, steel or non-combustible material.

Approved color (tested color): dark grey and brighter colors

Maximum organic content: 51 %

Mixing ratio (A : B): 10:1 by weight

Several layers of floor coverings are acceptable provided that each layer is approved according to the Marine Equipment Directive and bear the MED Mark of Conformity.

Each product is to be supplied with its manual for installation and maintenance.
