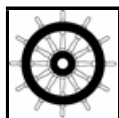

Product description

"FS-B1-G Type B-15 Class Bulkhead (High-Performance Soundproof Board)"
is a class B-15 bulkhead constructed of rock wool panels.

The bulkhead panels are composed of a rock wool core sandwiched between two 0.5 mm thick stainless steel sheets. The KMD-Y type rock wool of nominal density of 120 kg/m³, produced by Tianchang KMD New Insulation Materials is affixed to the steel sheets with an adhesive of approved type. The panels are jointed together by U-shaped clips (13 mm x 10 mm x 0.5 mm) on both sides. The panels are provided with 370 mm x 10 mm air gap centrally.

Total panel thickness: 50 mm

Application/Limitation

Approved for use as a vertical fire retarding division of class B-15.

Maximum panel size: 600 mm x 2460 mm (W x H).

The insulation materials and adhesives used have to be approved according to the Marine Equipment Directive and bear the MED Mark of Conformity. This requirement may also be applicable for surface materials used, if required by relevant rules and regulations.

Each product is to be supplied with its manual for installation and maintenance.
