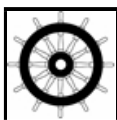

Product description

"A60-B-S-R Type Spray KH-R Rock Wool Product (Spray Coating) "A-60" Class Bulkhead"
is composed of a structural steel bulkhead, reinforced with six stiffeners of L65 x 65 x 6 mm angle steel along high direction and two flat steels 65 x 6 mm welded on upper and lower ends. Insulated with one layer of heat insulation material KH-R Rock Wool Product produced by Yixing Kunhao Fireproof Material with density of 110 kg/m³ and 40 mm thick fixed on the steel structural core and one layer 20 mm thick on the stiffeners.

Application/Limitation

Approved for use as a vertical fire retarding division of class A-60.

The insulation materials and adhesives used have to be approved according to the Marine Equipment Directive and bear the Mark of Conformity. This requirement may also be applicable for surface materials used, if required by relevant rules and regulations.

Each product is to be supplied with its manual for installation and maintenance.
