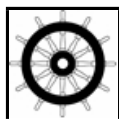

A U.S. Coast Guard approval number will be assigned to the equipment when the production module has been completed and will appear on the production module certificate (module D, E or F), as allowed by the Agreement between the United States of America and the EEA EFTA states on the mutual recognition of Certificates of Conformity for Marine Equipment signed 17 October 2005, and amended by Decision No 1/2023 dated August 21st, 2023.

Product description

"HANDTUFTED WOOL 100% H550/H650 CUT & LOOP"

is a wall-to-wall floor covering (rug or carpet) composed of three layers:

- 9 mm thick wool (density: 3.3 kg/m²),
- 1 mm thick cotton (density: 0.32 kg/m²),
- 2 mm thick synthetic latex with fire retardant (ZR-8825) (density: 1.2 kg/m²).

Max. thickness: 12 ± 0.5 mm

Density: 4.8 kg/m²

Application/Limitation

Approved for use as low flame spread material, not generating excessive quantities of smoke nor toxic products in fire.

Approved for all colour variations.

Maximum organic content: 77 %

Any adhesive used, other than the one used during testing, has to be tested for low flame spread characteristics according to IMO 2010 FTP Code Part 5 and to be approved according to the Marine Equipment Directive and bear the Mark of Conformity.

Approved for use as floor covering on any low flame-spread floor covering, steel or non-combustible material.

Several layers of floor coverings are acceptable provided that each layer is approved according to the Marine Equipment Directive and bear the MED Mark of Conformity.

Each product is to be supplied with its manual for installation and maintenance.
