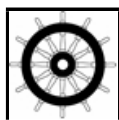

Product description

"BSCF-A60-96B Type Class A-60 Fire-resistant Bulkhead"

is composed of a structural core insulated with two layers of 20 mm thick BSCF type aluminosilicate blanket (96 kg/m³ density, manufactured by Hebei Guomei New-type Building Materials) applied on the steel plate and around stiffeners.

The insulation is fixed to the bulkhead with steel pins Ø3 mm and with steel washers Ø30 mm.

The pins are installed with maximum spacing of 300 mm in width direction and with maximum spacing 300 mm in length direction.

For further details see drawing(s) listed under Type Examination documentation.

Application/Limitation

Approved for use as a vertical fire retarding division of class A-60.

The insulation materials and adhesives used have to be approved according to the Marine Equipment Directive and bear the Mark of Conformity. This requirement may also be applicable for surface materials used, if required by relevant rules and regulations.

Each product is to be supplied with its manual for installation and maintenance.
