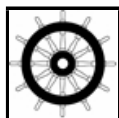

Product description

“Marine DBA60 Type A-60 Class Floating Floor”

is composed of a 4.5 mm structural steel deck (exposed side) insulated on top with 53 mm composite rock wool boards (unexposed side). The rock wool boards consist (from the bottom) of 50 mm thick YG-2 type rock wool with density of 150 kg/m³ (manufactured by Changzhou Thermal Insulation Material Factory Co., Ltd.) and a 3 mm thick steel plate affixed with an adhesive of approved type.

The adjacent plates were jointed by connectors L20 mm x 15 mm x 3 mm and by intermittent welding.

Total thickness: 57.5 mm.

Application/Limitation

Approved for use as a horizontal fire retarding division of class A-60.

Maximum panel size: 450 mm x 1960 mm (W x L).

The insulation materials and adhesives used have to be approved according to the Marine Equipment Directive and bear the MED Mark of Conformity. This requirement may also be applicable for surface materials used, if required by relevant rules and regulations.

Each product is to be supplied with its manual for installation and maintenance.
