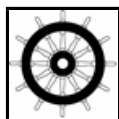

"NQF-II Type High Sound Insulation Floating Deck Covering"

composed of structural steel deck insulated on top with various layers as follows (from the bottom):

- 5 mm thick steel deck,
- 2 mm thick damping deck coating,
- 1.5 mm thick galvanized steel sheet,
- 20 mm thick layer of TG-II type ceramic wool (density 170 kg/m³, manufactured by Yixing Ocean Ship Material),
- PE waterproof film,
- φ 3mm steel mesh,
- 25-40 mm thick layer of NQH-II Type Light Fireproof Deck Covering (density 1500 kg/m³, manufactured by Nantong Ruipu Marine Covering and Paint Technology).

Application/Limitation

Approved for use as a horizontal fire retarding division of class A-60.

The insulation materials and adhesives used have to be approved according to the Marine Equipment Directive and bear the Mark of Conformity. This requirement may also be applicable for surface materials used, if required by relevant rules and regulations.

Each product is to be supplied with its manual for installation and maintenance.
