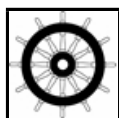

“Stengel Digitaldruck mit Rutschhemmung 2”

is a floor covering consisting of four layers:

- 0.075 mm UV primer, area weight 75 g/m²
- 0.020 mm black ink, area weight 20 g/m²
- 0.085 mm clear coating, area weight 85 g/m²
- 0.030 mm topcoat , area weight 30 g/m²

Density: 1050 kg/m³

Weight per unit area: 210 g/m²

Total thickness: 0.2 mm

Application/Limitation

Approved for use as low flame spread material, not generating excessive quantities of smoke nor toxic products in fire.

Approved for use as floor covering on any low flame-spread floor covering, steel or non-combustible material.

Approved for all colour variations.

Maximum organic content: 80 wt%

Several layers of floor coverings are acceptable provided that each layer is approved according to the Marine Equipment Directive and bear the Mark of Conformity.

Any adhesive used (if any), has to be tested for low flame spread characteristics according to IMO 2010 FTP Code Part 5 and to be approved according to the Marine Equipment Directive and bear the Mark of Conformity.

Each product is to be supplied with its manual for application and use.
