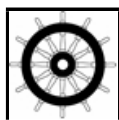

Product description

"LH Spray R-B401 Type A-60 Class Bulkhead"

is a heat insulation material applied on the stiffener side of a steel structural core bulkhead. The core steel plate is 4.5 mm thick and reinforced with stiffeners of L63 x 63 x 6 mm.

The insulation material is LH Spray R marine rock wool product produced by Shanghai Lihui Marine Equipment Co., Ltd. The Structure is a spray mix with a nominal density of 120 kg/m³. It is applied on the steel structural core with one layer of 40 mm nominal thickness and on the stiffeners with one layer of 20 mm nominal thickness.

For further details refer to the documentation listed below under "Type Examination documentation".

Application/Limitation

Approved for use as a vertical fire retarding division of class A-60.

The insulation materials and adhesives used have to be approved according to the Marine Equipment Directive and bear the Mark of Conformity. This requirement may also be applicable for surface materials used, if required by relevant rules and regulations.

Each product is to be supplied with its manual for installation and maintenance.
