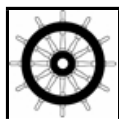

Approved for use as low flame spread surface material, not generating excessive quantities of smoke nor toxic products in fire.

Approved for use as paint system on a metallic substrate with thickness of at least 2.25 mm.

Approved for all colour variations

Max. organic content: 65.65 wt% per dry film thickness

The product satisfies the requirement for maximum calorific value (ref. SOLAS Chapter II-2, Reg 5.3.2.2) without further testing.
