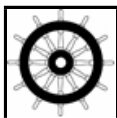

The product may also be used as floor covering in accordance with IMO 2010 FTP code part 5 appendix 4 paragraph 4.9.2.

The product may be applied over any steel or non-combustible material.

Approved colour: Light grey and brighter colour

Maximum organic content: 4.5%.

Mixing ratio: 42% water

Not to be used as an integrated part of a horizontal class A division unless tested as such.
