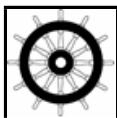

A U.S. Coast Guard approval number will be assigned to the equipment when the production module has been completed and will appear on the production module certificate (module D, E or F), as allowed by the Agreement between the European Community and the United States of America on Mutual Recognition of Certificates of Conformity for Marine Equipment, signed February 27th, 2004, and amended by Decision No 1/2023 dated May 26th, 2023.

Product description

"Class A-60 Deck: HMTD1-96"

composed of structural steel deck insulated with one layer of 30 mm ceramic wool HMT-96 (density of 96 kg/m³, manufactured by Tianjin Haimen Building Material) between and around the stiffeners. The insulation is fixed by Ø3 mm steel pins with Ø30 mm washers.

Pins between stiffeners are positioned in square pattern in such manner that the maximum distance between pins is 300 mm horizontally and 300 mm vertically. Maximum distance between insulation panels joint and pins is 150 mm.

For further details, see drawing listed under Type Examination documentation below.

Application/Limitation

Approved for use as a horizontal fire retarding division of class A-60.

The insulation materials and adhesives used have to be approved according to the Marine Equipment Directive and bear the Mark of Conformity. This requirement may also be applicable for surface materials used, if required by relevant rules and regulations.

Each product is to be supplied with its manual for installation, use and maintenance.
