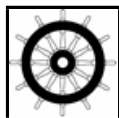

is a low flame-spread surface material mainly composed of glass fiber and PU-50 type PU-50 type polyurethane adhesive.

Nominal thickness: 0.1 - 0.2 mm

Weight per unit area (Glass Fibre Fabric): $140 \pm 10\%$ g/m²

Application/Limitation

Approved for use as low flame spread material, not generating excessive quantities of smoke nor toxic products in fire.

Approved for use as decorative veneers on any non-combustible substrate.

Approved colour: white

Maximum organic content: 48%

The product satisfies the requirement for maximum calorific value (SOLAS Reg. II-2/5.3.2.2) without further testing.

Any adhesive used, other than the one used during testing, has to be tested for low flame spread characteristics according to IMO 2010 FTP Code Part 5 and to be approved according to the Marine Equipment Directive and bear the Mark of Conformity.

Each product is to be supplied with its manual for installation and maintenance.
