Application/Limitation

Approved for use as combustible insulation material with low flame-spread characteristics, not generating excessive quantities of neither smoke nor toxic products in fire.

Approved colour: grey

Maximum organic content: 4.5%

The combustible insulation with low-flame spread characteristics may be used in cargo spaces, mail rooms, baggage rooms and refrigerated compartments of service spaces as well as for cold service pipework/fittings for refrigeration systems (SOLAS Reg. II-2/5.3.1.1). Piping for hot and cold sanitary water is not regarded as "cold service pipework/fittings".

The product satisfies the requirement for maximum calorific value (ref. SOLAS Chapter II-2, Reg 5.3.2.2) without further testing.

Extent of application is to be considered and accepted for each case/project.

Each product is to be supplied with its manual for installation and maintenance.
