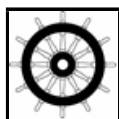

Product description

is a glass fiber fabric (silver white color) of 0.17mm nominal thickness with a surface density of 210g/m² manufactured by Shanghai ABM Rock Wool Dafeng and glued to substrate with an AQUECE PL 3109 type composite adhesive (max. applied weight: 70g/m²).

Application/Limitation

Approved for use as low flame spread surface material, not generating excessive quantities of smoke nor toxic products in fire.

Approved for use as decorative veneer on non-combustible, non-metallic substrate with a greater density than 37.5 kg/m³.

Approved colour: white
Max. organic content: 0%

The product satisfies the requirement for maximum calorific value (ref. SOLAS Chapter II-2, Reg 5.3.2.2) without further testing.

Any adhesive used, other than the one used during testing, has to be tested for low flame spread characteristics according to IMO FTP Code Part 5 and to be approved according to the Marine Equipment Regulation and bear the Mark of Conformity.

Each product is to be supplied with its manual for installation, use and maintenance.
