“ Entrance Mat LWT ”

A tufted carpet consisting of a pile of 80% wool and 20% nylon and a polyamide (PA) monofilament, precoated with SBR latex and PP film on a backing of polypropylene (textile).

Total thickness: 9.6 mm

Carpet weight: 2.0 kg/m²

Max. organic content: 44%

Colour: Dark grey / black

For testing on the standard calcium silicate board, the glue Ege 90 RH was used.

For further details refer to the documentation listed below under “Type Examination documentation”.

Application/Limitation

Approved for use as low flame spread material, not generating excessive quantities of smoke nor toxic products in fire.

Approved for all colour variations.

Approved for use as floor coverings on any non-combustible, non-metallic substrate.

Several layers of floor coverings are acceptable provided that each layer is approved according to the Marine Equipment Regulation and bear the Mark of Conformity.

Any adhesive used, other than the one used during testing, has to be tested for low flame spread characteristics according to IMO 2010 FTP Code Part 5 and to be approved according to the Marine Equipment Regulation and bear the Mark of Conformity.

Each product is to be supplied with its manual for installation, use and maintenance.
