'SMLR-D-12, SMLR-D-16, SMLR-D-20, and SMLR-D-25',
Davit-launched inflatable liferafts.

Trade names: CSM, OCEAN SOLAS, SEAGO

Application/Limitation

The liferaft shall be packed with a SOLAS A PACK or SOLAS B PACK.

Gas cylinders shall be of an approved type.

Components in the gas inflation system should be approved according to ISO 15738:2019.

The liferaft is intended to be installed with external weak link and a hydrostatic release unit. Float free arrangement to be checked upon installation on board.

The liferafts which have a mass above 185 kg may not be used for positions where side to side transfer is necessary.

The design assessment is based on International Life-Saving Appliances (LSA) Code, IMO Res. MSC 48(66) as amended by IMO Res. MSC.218(82), IMO Res. MSC.293(87) and IMO Res. MSC. 481(102).

Production testing shall be carried out according to IMO Res. MSC.81(70) Part 2 as amended.
