 - Glazing frame is attached to body frame by hinges, 3 off, made of SS and glass filled nylon or polycarbonate
 - Glazing frame is locked by thumb turn assemblies, 5 off, made of SS and glass filled nylon or cast SS with silicone bronze inserts
 - Seal of rectangular shaped silicone rubber, glued to the glazing with silicone adhesive, alternatively is a seal made of EPDM with self backed adhesive used
 - MCA versions of the portlights are fitted with a lockable dog and removable SS storm shutter

May be used on Recreational Craft subject to CE-marking according to Directive 94/25/EC as amended, in location areas *Area I*, *Area IIb*, *Area III* & *Area IV* on *Any* Craft Type of *Any* Design Category as specified in ISO12216
