Periodical assessment

- Results from Routine tests (RT) checked (if not available tests according to RT to be carried out)

- Ensuring traceability between manufacturer's product type marking and Type Approval Certificate.

Periodical assessment is to be performed after 2 years and after 3,5 years. A renewal assessment will be performed at renewal of the certificate.
