"KCC Cerakwool New Bio Alpha 1200(70K) + G.C.F(612, 10 µm)".

Consist of an aluminium foil and layer of glass fiber cloth faced to "KCC Cerakwool New Bio Alpha 1200" ceramic fiber with glue.

Ceramic fiber from KCC GIMCHEON PLANT

Density: 70 kg/m³.

Aluminium foil and glass cloth fabric from Go Sung System

Aluminium thickness: 10 µm.

Fiber glass thickness: 120 µm.

Alternative adhesives:

A) Water glass from DC Chemical Co., Ltd.

B) Polyethylene from Yulim Industry Co., Ltd.

"KCC Cerakwool New Bio Alpha 1200(70K) + G.C.F(612, 10 µm)":

Maximum product thickness: 40 mm.

Application/Limitation

Approved for use as low flame spread surface material, not generating excessive quantities of smoke nor toxic products in fire.

Approved colour: white.

Maximum organic content: 1%.

Approved for use as decorative veneer on any non-combustible substrate.

Any adhesive used, other than the one used during testing, has to be tested for low flame spread characteristics according to IMO 2010 FTP Code part 5.

The product satisfies the requirement for maximum calorific value (ref. Solas Chapter II-2, Reg 5.3.2.2) without further testing.

Each product is to be supplied with its manual for installation and use.
