Product description

HilonUprimer 3105; two-component, epoxy based, coatings for corrosion protection of steel surfaces.

Application/Limitation

This approval is solely connected to the corrosion prevention properties of the coating material. The approval does not include any evaluation of toxicity, contamination, pollution, or fire technical properties.

HilonUprimer 3105 is approved for application on blast cleaned surfaces and on prequalified shop primed surfaces. The following shop primers have been prequalified:

Surface preparation and coating application as per PSPC or manufacturer's recommendations, whichever is stricter.
