Product description

704 Inorganic Zinc Silicate Shop Primer

Application/Limitation

The shop primer is approved for application on blast cleaned steel plates and sections.

The approval does not include any examination of possible effects of welding with this primer on the welders' state of health.

This approval verifies only that the shop primer tested has no detrimental effect on the finished weld, presuming that the film thickness applied is in accordance with the manufacturer's recommendation.

Type Approval documentation

Tests carried out

Type Testing carried out according to **Type Approval documentation**, ref. Test Report W0713 by Synthetic Test Institute, Hudong-Zhonghua Shipbuilding Group Co. Ltd., Shanghai dated 2007-09-13, with the following result:

- Mean pore area 16 mm² (max. allowed pore area 125 mm²)

Marking of product

Product/package shall be marked with *manufacturer's name and address*; **Zhejiang Feijing New Material Science & Technology Co., Ltd., China**, *type designation*; **704 Inorganic Zinc Silicate Shop Primer** and *date of production/batch number*.

The marking is to be carried out in such a way that it is visible, legible and indelible. The marking of product is to enable traceability to the DNV GL Type Approval Certificate.

Periodical assessment

The scope of the Periodical Assessment is to verify that the conditions stipulated for the Type Approval is complied with and that no alterations are made to the product design or choice of materials.

Periodical Assessment to be performed after 2 and 3.5 years (Certificate Retention) and at renewal after 5 years (Certificate Renewal).

The main elements of the Periodical Assessment are to:

- Review design, materials, production process, and performance with respect to possible changes, in order to ensure compliance with **Type Approval documentation** and/or referenced material specifications.
