Y-M3-FWP

Flat Wall Panel **Y-M3-FWP** is an insulation panel used in cryogenic containment system based on GTT's Mark III/FLEX membrane design. It is made by plywood, reinforced rigid polyurethane foam, PU adhesive, rigid secondary barrier, anchoring strip, Al rivet and metallic insert, as detailed in manufacturer's technical data sheet: Y-M3-FWP.

Application/Limitation

Materials and components used in manufacturing of Y-M3-FWP (as detailed in the Technical Data Sheet) shall be in accordance with relevant GTT specifications.

The product Y-M3-FWP is only approved for use in MARK III/FLEX Cargo Containment Systems (CCS) type LNG carriers built under license from GAZTRANSPORT & TECHNIGAZ SA (GTT).

Deliveries to actual shipbuilding projects shall be in compliance with the "MarkIII: Flat Wall Panels Prefabricated Elements" specification, GTT document no. M3105, Rev. 06 dated September 2017.
