Responsibility

The Company (stated on the front page of this Certificate) takes the responsibility that both design and production are in compliance with Rules, Standards and/or Regulations listed on page 1 of this certificate.

Application/Limitation

This approval is solely connected to the corrosion prevention properties of the coating material. The approval does not include any evaluation of toxicity, contamination, pollution, or fire technical properties.

Interline 704HS is approved for application on blast cleaned surfaces and on prequalified shop primed surfaces. The following shop primer has been prequalified:

- Interplate 937 [International Paint Limited]

Surface preparation and coating application according to PSPC or manufacturer's recommendations, whichever is stricter.

The durability of the applied coating system will depend on the steel surface preparation, coating application and the environmental conditions.

The Type Approval Certificate is invalid if the formulation of the epoxy coating **Interline 704HS** is changed to a degree deemed significant by DNV. If the formulation of the listed pre-qualified shop primer is changed to a degree deemed significant by DNV the shop primer cannot be used as part of the Protective Coating System.
