Application/Limitation

When applying the gelcoat, the layer must be 500 to 800 microns thick, depending on the intended use of the product manufactured.

The base resin (AROPOL® S 573) properties meet ISO 12215-1 Type A requirements, with a note that the water absorption in accordance with ISO 62 is >80 mg, i.e. 87.8 mg. Extensive testing and a well-established performance history confirm its good resistance to water, hydrolysis, and osmosis.

Any significant changes in design and / or quality of the material will render the approval invalid.
