Product description

Waterjet with built-in steering and reversing system.

Application/Limitation

The approval is valid for propulsion duty with the following rating:

Maximum input power	2070 kW
Maximum impeller speed	1695 rpm
Maximum torque	11665 Nm
Application factor, K_A	1.3

The waterjet is to be run within safe operation range (no harmful cavitation) to achieve a satisfactory lifetime. Service interval shall correspond with calculated lifetime of bearings.

Marking of product

The product shall be marked with the manufacturer's name or trademark and type designation.

Periodical assessment

For retention of the type approval, a DNV surveyor shall perform an assessment after 2 years and after 3.5 years, to verify that the conditions of the type approval are complied with. A renewal assessment will be performed at renewal of the certificate.

In cases where the type approved product is manufactured at other companies, the periodical assessment shall verify that the type approval applicant has a quality control system for consistent production at their licensees/subcontractors. Furthermore, periodical assessment shall be carried out randomly at these companies.

Other conditions

The following is not covered by this certificate and shall be submitted for approval for each delivery:

- Connection to hull (shipbuilders responsibility)
- Connection to driving unit
- Controls and alarms, including set points and delays
- Remote control system
- Interceptor
- Hydraulic cylinders for steering and reversing shall be type approved or approved on a case-by-case basis
- Flexible hoses shall be type approved
