Screwed-on valve bonnets are normally not to be used for valves with nominal diameter exceeding 40 mm in Class I piping systems, for valves on ship's side and bottom and for valves in systems for flammable fluids. (DNV Ship Pt.4 Ch.6 Sec.8 C103).

Each valve body shall be subjected to a hydrostatic pressure test at minimum 1.5 times the design pressure. The test pressure need not be more than 70 bar in excess of the design pressure.

Holding time: 2 min. for sizes up to 100 mm/4"
5 min. for sizes 125 - 250 mm/5" - 10",
10 min. for sizes 300 mm - 450 mm/12" - 16",
No leakage is permitted.

Each valve assembly shall be subjected to a hydrostatic seat leakage test. The test pressure shall at least be equal to the design pressure. The test shall be performed with closed valve with the other end open to atmosphere. The pressure shall be applied independently on each side.

Holding time: 5 min. for all sizes.
Acceptable leakage range: Drop tight

Certification

DNV product certificates are required for valves with D N > 100 mm and PN > 16 bar and for ship side valves where DN > 100 mm regardless of pressure rating. For other valves manufacturer's certificate may be accepted.

Material certificates for the valve bodies are required in line with DNV Ship Pt.4 Ch.6 Sec.2 Table A2. Note that the complete refrigerant circuit, including both low and high pressure sides, shall be considered as pertaining to Class II piping systems except R744 (CO₂) with design pressure above 40 bar which shall pertain to Class I (DNV Ship Pt.4 Ch.6 Sec.6 E103).

Marking of product

Each valve shall be clearly marked for identification. The identification marking may be performed on the body or on a plate of non-corrosive material. When a metallic plate is used, the plate shall be permanently fixed to the body.

Identification marking on the body shall be located to nonstressed areas and shall be clearly legible. The identification marking shall as a minimum include the following:

- manufacturer's name or trade mark
- valve type designation
- size
- maximum design pressure or pressure class
- arrow to indicate direction of flow on one way flow valves.

Periodical assessment

For retention of the Type Approval, a DNV GL Surveyor shall perform a survey - every second year and before the expiry date of this certificate - to verify that the conditions for the type approval are complied with.
