Product description

Rotor Sail 28 x 4m and Rotor Sail 28 x 4m IECEx. Wind assisted propulsion system with fixed foundation.

Application

General:

Norsepower Rotor sail system 28 x 4m and Rotor Sail system 28 x 4m IECEx with fixed foundation underwent a **design assessment** according to DNV-CG-0550, Sec.3 [3.2.1].

The Type Approval Design Certificate is valid for the type and version described and the conditions defined in the design documentation.

The design of the Norsepower Rotor sail system 28 x 4 and Rotor sail system 28 x 4 IECEx has been approved with regards to an installation on ships, including the design loads and environmental conditions as specified in DNV-ST-0511 Wind assisted Propulsion systems. For Norsepower Rotor sail system 28 x 4 IECEx, the ex-protection has been reviewed and approved with regards to a possible installation in hazardous zones (as per definition of IEC 60079 and 60092-502), with limitations as defined below.

Limitations:

This Type Approval covers design(s) only, i.e. the Type Approval Design Certificate is not covering:

- The ship-specific foundation of the rotor sail
- Requirements arising from Classification aspects of the ship on which the rotor sail will be installed on, i.e. type approval of rotor sail associated equipment, materials and others, as laid out in DNV Rules for Classification RU-Ship Pt.6 Ch.2 Sec.12
- Requirements arising from Classification aspects of the ship on which the rotor sail will be installed on, related to installations in hazardous areas
- Supervision of construction
- Supervision of testing

As such, this Type Approval is not covering the final product but may be used as basis for obtaining a product declaration (PD).
