¹⁾ tare mass is to be confirmed by weighing. The sum of the tare mass and the payload shall never exceed the Max. gross mass as it is stated on the front page of this certificate.

This design partly complies with ISO 1496-5. The following deviations have been accepted:
- the container is not equipped with gooseneck tunnel as required by the standard. This should be included in each container certificate.

Application/Limitation

The following text to be included in each certificate:

"Gas cylinders can be transported in this frame. However, if the gas cylinders are fixed and are connected via manifolds, the unit as a whole (frame and gas cylinder installation) is defined as a MEGC (Multiple Elements Gas Container). According to the IMDG Code Ch. 6.7.5, MEGCs must be approved and certified by an authorized certifying body."

Note that the ISO Type Code is not applicable for MEGCs and will have to be changed if the container is certified as MEGC.

Production tests to be carried out as required by DNV GLs surveyor.

DNV GL surveyor has to witness important production and test events and issue Form no. 49.02a "Freight Container Certificate" for all containers. Each certificate can cover a batch of containers.

Type Approval documentation

Tests carried out

Prototypes strength tested according to requirements.

Marking of product

Each container to be marked with:

- Data Plate according to CSC requirement including Allowable stacking load for 1.8g of 213360 kg
- External marking according to DNV/ISO 6346 requirements
- DNV GL decal for freight containers
-  mark to be hard stamped on frame

Periodical assessment

For retention of the Type Approval, a DNV GL surveyor shall perform an assessment every 2nd year and before the expiry date of this certificate to verify that the type approval is complied with.
