- Top cover frame shall be clearly marked "lifting eyes not for lifting container" or similar.

Periodical assessment

In order to maintain the validity of this type approval certificate, periodical assessments should be carried out in accordance with DNVGL-SE-0284 at 2 and 3.5 year intervals. Periodical assessments will, when possible, be harmonised with other surveys and audits carried out.
