- Production testing: At least 2% of the items delivered are to be selected and subjected to the test load
- For use as lifting twistlock each item needs to be tested and marked according to DNV standard ST-0377
- Material tests are to be included energy testing at -20°C, with the impact energy requirements acc. to DNVGL-CP-0068. The material shall be according to the approved drawings. Maternal certificates shall be 3.1 acc. to DIN EN 10204.
