- The container shall be clearly marked near each set of fork lift pockets with the words "Empty Lift Only" in accordance with DNV-ST-E271 section 6.1.

Periodical assessment

In order to maintain the validity of the type approval certificate, periodical assessments should be carried out according to DNV-SE-0284 at 2 and 3.5 year intervals. Periodical assessments will, when possible, be harmonised with other surveys and audits carried out.
