Production tests to be carried out as required by DNV surveyor. DNV surveyor to witness important production and test events and issue Form no. CTC 301 for all containers. Each certificate can cover a batch of containers.

The unit has increased weight compared with standard 40ft CSC frame and must be clearly marked accordingly.

This approval does not apply to the gas cylinders to be installed in this container. When gas cylinders are installed and connected by manifolds, the unit as a whole will become a Multiple Element Gas Container, MEGC, and must be approved and certified as such in accordance with the ADR and/or RID codes by an authorised certifying body.

Note that the ISO Type Code is not applicable for MEGCs and will have to be changed if the container is certified as MEGC.

Tests carried out

Prototype 503 strength tests performed and witnessed by DNV according to CSC (ISO 1496-1).

Marking of product

Each container to be marked with:

- Data Plate shall be in accordance with CSC requirements, include allowable stacking and racking values
- External marking shall be in accordance with ISO 6346 requirements
- DNV decal for freight containers
- NV mark to be hard stamped on frame

Periodical assessment

In order to maintain the validity of the type approval certificate, periodical assessments should be carried out according to DNV-SE-0284 at 2 and 3.5 year intervals. Periodical assessments will, when possible, be harmonised with other surveys and audits carried out.
