Special D-shackle for mooring chains with sizes up 6965 kN / 710 ton.

Application/Limitation

The Shackle is to be used in Temporary, Mobile and Long-Term Mooring lines as defined in Offshore Standard DNV-OS-E301 Position Mooring July 2021.

The Shackle shall be manufactured and tested in accordance with Offshore Standard DNV-OS-E302 Offshore Mooring Chain July 2022.

The approval is conditional that manufacturer is holding an Approval of Manufacturer DNV Certificate. Individual Product Certificate is to be issued for each delivery.

Type Approval documentation

Tests carried out

For every order, testing shall be carried out according to DNV-OS-E302 July 2022.

Marking of product

Each shackle shall be marked according to Offshore Standard DNV-OS-E302 July 2022 Ch2 Sec2 §1.4 & §3.9.

Periodical assessment

For retention of this Type Approval, a DNV surveyor shall perform a periodical assessment after two years (+/- 90 days) and after 3.5 years (+/- 90 days).
