H links for mooring chains sizes between Ø50mm and Ø165 mm in R3, R3S, R4 and R4S grades. The H link dimensions are defined as a function of the chain diameter.

Application/Limitation

The approval is conditional that the manufacturer is approved by DNV for the selected R grade material and size. The H links are to be used in connection with chains for Temporary, Mobile and Long-Term Mooring as defined in Offshore Standard DNV-OS-E301 "Position Mooring" July 2021.

The H links shall be manufactured and tested in accordance with Offshore Standard DNV-OS-E302 "Offshore Mooring Chain" July 2022.

Individual Product Certificate is to be issued for each delivery.
