#### Marking of product

Each container to be marked in accordance with DNV / ISO requirements, including:

- Data and inspection plates
- DNV emblem for offshore containers
- NV mark to be hard stamped on the data plate
- Manufacturer's Serial Number to be welded on frame
- The container shall be marked with words to the effect of "Only to be used in temperate climates", as per DNV-ST-E271 section 10.

#### Periodical assessment

In order to maintain the validity of the type approval certificate, periodical assessments should be carried out in accordance with DNV-SE-0284 at 2 and 3.5 year intervals. Periodical assessments will, when possible, be harmonised with other surveys and audits carried out.
